On 29 May 2020, at [REDACTED] [REDACTED]@ec.europa.eu wrote:

Dear Sir,

We refer to your letter dated 18 September 2019 in which you make a request for access to documents, registered on 24 September 2019 under the above-mentioned reference number. We also refer to our email dated 8 November 2019 in which we informed you that the wording of your request is not precise enough to yield results in the document management systems/project websites/reporting tools of the European Commission and requested you to provide clarifications. You replied to said request by letter dated 2 December 2019 (transmitted via email dated 2 December 2019).

First, we would like to welcome the clarifications provided on the geographic area covered by your request. Point 1 of your letter dated 2 December 2019 mentions: *'third countries should be deemed to mean in the following countries: Turkey, Montenegro, North Macedonia, Albania, Serbia, Kosovo, Bosnia and Herzegovina, as well as any African country'*. Please note that, for DG DEVCO, the geographic coverage of the request would concern countries of sub Saharan Africa, which fall under its mandate<sup>[1]</sup>. The rest of the countries/areas mentioned in your letter of 2 December 2019 fall under the remit of DG NEAR, which is currently handling access to documents request under reference GestDem 2020/5444 submitted by your organisation.

On a second point, we notice that in your reply of 2 December 2019, you have proposed additional DAC codes for the identification of projects/documents, thus expanding the scope of your request. Moreover, the proposed DAC codes do not relate to the areas of interest or activities you describe in your initial application, nor in the subsequent reply to the request for clarifications. For example, DAC code 15110 includes projects such as *'Programme Sécurité Alimentaire et Nutritionnelle composante Santé Nutrition (CSN-SAN) in Chad'* or *'Profile Environmental de Pays du Mali'* which are completely unrelated to the areas mentioned in the letters received so far by your organisation and which focus on surveillance, policing border control, etc.

Based on the description given in your application and the reply to the request for clarifications, we consider that DAC code 15210 is the most appropriate to search for projects/programmes containing the documents you are requesting.

Thirdly, we would like to recall the fact that the European Commission channels funds to recipients through different types of management modes, which are governed by distinct rules, procedures and obligations, amongst which through indirect management with International Organisations and Member States' agencies. In the latter case, the Commission delegates the implementation of an action to the designated entities, which are entitled to make use of their own systems and procedures for the implementation; as a consequence, the bulk of information related to the action stays with them and is not communicated to the Commission.

As a consequence, research for such projects or documents would generate an excessive administrative burden for Commission services without at the same time guaranteeing effectiveness of the search results. We, therefore, propose to provide you with a list of projects carried out under direct management and indirect management with partner countries.

On the basis of the above criteria (DAC code 15210, African countries under DEVCO's mandate, projects under direct management and indirect management with partner countries implemented from 01-01-2017 to 31-08-2019) DG DEVCO has identified the below list of 45 projects, each of them including an average of over a hundred documents per project, some containing over two hundred names each

This very large number of documents need to be assessed individually. Such a detailed analysis cannot be carried out within the normal time limits set out in Article 7 of Regulation (EC) No 1049/2001.

However, Article 6(3) of Regulation (EC) No 1049/2001 also provides for a possibility to confer with an applicant informally with a view to finding a fair solution when an application relates to a very long document or concerns a very large number of documents.

In accordance with the case law of the EU Courts, such a solution can only concern the content or the number of documents requested, not the deadline for replying <sup>[2]</sup>. This means that the scope of the request must be reduced in a way that would enable its processing within the extended deadline of 15 + 15 working days.

Based on the above-mentioned provision, we would kindly ask you to specify the objective of your application and your specific interest in the documents requested <sup>[3]</sup>, and whether you could narrow down the scope of your application.

In order to help you narrow down your request, please note that the following categories of documents have been identified as falling under the scope of your request:

According to our first estimates, the handling of your request would take 45 working days<sup>[4]</sup> per project, broken down as follows:

- identification of the documents falling under your request: 5 working days;
- retrieval and establishment and verification of a complete list of the documents identified: 3 working days;
- assessment of the content of the documents in light of the exceptions of Article 4 of Regulation (EC) No 1049/2001: 20 working days;
- drafting of the reply: 2 working days;
- drafting of those parts of the documents to which one or several exceptions apply(ies): 7 working days;
- internal review and approval of the draft decision on your request: 3 working days;
- preparation of the reply and the documents for dispatch (scanning of the redacted versions, administrative treatment,...): 5 working days.

It follows that, according to our first estimates, the documents that could possibly be dealt with within the extended deadline of 30 working days would concern a maximum of 2 projects included in the above list.

In order to enable us to respect the time-limits of Regulation (EC) No 1049/2001, we would ask you for a swift reply to our invitation to propose a fair solution, within five working days at the latest:

In the absence of a reply within five working days, we will unilaterally restrict the scope of your application to those parts that can be dealt with within the extended deadline of 30 working days.
